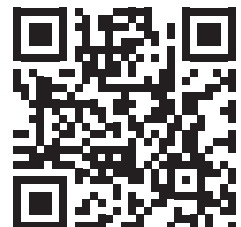

Workplace Representation

As an INMO member you will have access to:

- **Your Local Nurse/Midwife Representative**

The INMO representative is responsible for daily management of Industrial Relations, Health & Safety and general advice to members.

- **Your Geographical Branch Officer**

The INMO provides opportunities for all members to meet regularly through your relevant geographical branch and/or workplace.

- **Your Full-Time Industrial Relations Team**

The INMO offers a comprehensive industrial relations service through highly qualified Industrial Relations Officers. These officials represent members on collective and individual issues in local workplaces and, when necessary, to external third parties such as, Workplace Relations Commission (WRC), Adjudication or Labour Court.

Fitness to Practise

The INMO has a Specialised Professional / Legal Team to handle all aspects of representation at Hearings before the Fitness to Practise Committee of the Nursing and Midwifery Board of Ireland and the High Court, where an application is made to suspend a nurse/midwife pending an Inquiry. Such representation is subject to certain terms and conditions and a copy of said conditions can be obtained by contacting the Regulation Department.

Professional Indemnity Insurance Cover

Your membership provides valuable cover through our Professional Indemnity Insurance Policy for any member in the private healthcare sector engaged in normal nursing duties, e.g. agency or private nursing home work. All members wishing to avail of this policy must notify our membership department as there are certain limited exceptions to this policy.

The INMO is the only Irish affiliate to the International Council of Nurses (I.C.N.), the International Confederation of Midwives (I.C.M.), the Standing Committee for Nurses and Midwives in the European Union (E.F.N.) and the Nursing, the European Forum for National Nursing and Midwifery Associations (EFNMA), European Midwives Association (EMA) and the European Nursing Students Association (ENSA) and Midwifery Committee of the World Health

Organisation (W.H.O.). INMO is also a member of EPSU.
